## Spotlight on: Jennie Hannan

Principal Clinician/Family Law Services Consultant, Anglicare

My name is Jennie Hannan and I currently represent Anglicare WA on the Family Law Pathways network.

Anglicare WA has provided services across WA for the last 35 years including separation services, counselling, emergency relief, housing, youth and community development/support services to communities in 40 locations from Kununurra to Albany.

Anglicare WA works with people, their families and communities to enhance their abilities to cope with the challenges of life and relationships and has a significant role in advocacy at both a State and National level.

Anglicare WA's long standing commitment to quality service provision has meant the employment of a number of consultants specialising in Aboriginal culture, children, family law and domestic violence who provide high level consultation and advice across the agency.

Since early 2000 in the area of Family Law Anglicare WA has provided the following services:

### Children's Contact Services (Albany, Bunbury, Leederville, Joondalup)

Children's Contact Service provides a safe, child-focussed environment in which parents can arrange to spend time with their children after a family separation. Children's Contact Services offer both supervised visits and changeovers

### The Parenting Orders Programme (Mum's and Dads Forever) Statewide

Mums and Dads Forever helps parents understand how conflict impacts on children and young people. It assists parents to manage conflict and communicate with their former partner. The needs of the children and young people are always the focus.

### The Supporting Children after Separation Programme (Perth metro)

Supporting Children after Separation provides a safe and confidential space for children and young people to discuss their parent's separation with a counsellor, and to develop understanding and skills in order to manage this new family situation. This programme runs a number of groups for children as well.

### Family Relationship Centres (Joondalup, Mandurah and Broome)

Family Relationship Centres make it easier for families to access the many support services available in the community. The Centres are child-focussed and the needs of the children are seen as paramount. Family Relationship Centres provide Family Dispute Resolution and, where it is deemed appropriate, the practitioner may also include the children in the process.

### Step Families Australia Service Provider

Family Separation Services recognises the important role of step parents and understands that they may need extra support as the family experiences change. Family



Separation Services offers groups and counselling for step parents.

These services are supported by general, men's and domestic violence counselling services.

Anglicare also provides quality training programmes for the sector as well as an EAP programme to assist employees with issues that may affect their staff. (counselling, mentoring, critical incident debriefing)

In my current role as the Principal Clinician/Family Law Consultant I provide practice and service model advice within Anglicare WA and I am responsible for managing the complaints policy and the serious issues policy as well as developing and delivering training.

I have been with Anglicare for over 13 years and have over 30 years' experience as a social worker, therapist and Manager having worked for a number of government and not for profit agencies across Australia. Apart from my work with Anglicare I sit on a number of community boards and advisory bodies including the Family Law Council of Australia, Northern Suburbs Community Legal Centre board, the DCPFS case review board, the Family Court of WA Reference group, and the Child Support Agency National Engagement group. In the past I have also had the opportunity to be a member of the Families Australia Board and a member and chair of the Family Relationship Services Board.

## Recovery Order Self Help Guide: new online resource for the public

The Recovery Order Self Help Guide is a new online community legal education resource developed by Legal Aid WA and the Geraldton Resource Centre. The guide is available for free to members of the public across Western Australia. It can also be utilised by service providers.

This project was funded by the National Broadband Network Regional Legal Assistance Program to assist disadvantaged and vulnerable people in the Geraldton area and extending to the wider public in regional and metropolitan WA.

The guide can now be accessed from the Legal Aid WA website by going to [www.legalaid.wa.gov.au/CORE](http://www.legalaid.wa.gov.au/CORE). First time users will need to register and create a password before logging in. Users do not need an email address to register.

The guide provides step by step practical information about recovery orders including checklists, sample orders, an example filing letter to the Court and “how to” videos by experienced family lawyers. The guide is user friendly with legal processes and procedures explained in plain English with the option of using an audio function to listen to the text.

The guide is not intended to replace legal advice, and the “Help and links” section includes details of a range of legal service providers and other useful contacts.

There are a range of ways the guide could be used. People may view the guide from start to finish. Alternatively they may access it for information on a particular matter such as “What happens in Court?” or look at a checklist or example letter.

The guide can be used on a range of devices including laptops and tablets wherever a good internet connection is available such as at a local library or community resource centre.

## Seminar: Problems and Possibilities in Responding to Domestic and Family Violence Perpetrators

Curtin University presents a one hour seminar from Professor Cathy Humphries from the University of Melbourne at the School of Occupational Therapy and Social Work.

The last decade has seen in a shift in the prominence given to interventions which support the accountability of men who use violence and abuse. The area is replete with difficulties about focus (primary or tertiary prevention), the confused and developing evidence base, role of the criminal and civil justice system; the role of collaborative risk assessment and risk management; the interface with both child protection and family law – to mention just a few of the issues facing both practice and policy workers trying to develop coherent intervention frameworks. This presentation will focus on the role and positioning of men’s behaviour change programs within the wider system of intervention with a particular focus on the Victorian context.

## Thinking About Children: How Does It Influence Policy and Practice?

Childhood studies and sociocultural theory, together with the United Nations Convention on the Rights of the Child, have influenced policy and practice initiatives, both within New Zealand and internationally. The integration of children's agency, rights, and well-being provides a conceptual framework for positioning children as participating subjects, knowers, and social actors, rather than as the passive objects of socialization. Children are now considered to be people who can make a difference and contribute to creating their own futures and to sustaining their families, schools, and communities. Children's ability to express their views and exercise responsibility is influenced by their social and cultural contexts and the extent to which there is space and support for their participation. Sociocultural contexts play an important part in inducting children into shared meanings, values, and practices and enabling children to participate and learn. This chapter highlights three specific examples of

New Zealand's social policy and professional practice to explore how contemporary conceptions of childhood can influence children's rights and well-being – (1) early childhood education, (2) the abolition of physical punishment, and (3) ascertaining children's views in family law proceedings.

## Family law court filings 2004-05 to 2012-13

This report analyses trends in family law court filings over a nine year period between 2004-05 and 2012-13. It sheds light on the impact on court filings of the 2006 reforms that encouraged greater use of non-court based mechanisms for resolving parenting disputes and the 2009 reforms that brought post-separation property division laws and processes for de facto couples into line with those for married couples.

This report extends the findings of the 2009 study Evaluation of the 2006 Family Law Reforms. The research is based on data provided by the Family Court of Australia, the Federal Magistrates Court, and the Family Court of Western Australia, for the period 2004-05 to 2012-13.

## From Investigation to Collaboration: Practitioner Perspectives on the Transition Phase of Parental Agreements

Internationally there is a growing trend to implement alternative pathways within statutory child protection. This trend has emerged in response to burgeoning pressures on statutory child protection authorities and research highlighting the potentially negative impact of intrusive interventions on families. There is great diversity in the types of alternative pathways that have been implemented across jurisdictions. Differential response and parental agreements are two examples of alternative pathways that can be enacted for cases that warrant ongoing intervention.
