REGISTRATION TERMS AND CONDITIONS

Who can register?

- 1. Registrations are only available for **specific, named individuals** who will be attending the conference.
- 2. It is **not possible to purchase generic places** where the attending delegate is not yet known. This is because to register someone, we require individual information such as their dietary needs, access requirements and contact details. Therefore, please determine who will be attending before attempting your booking.
- 3. Registrations may not be shared between delegates. Each person must register separately, and places may not be "split" between people.

How to register

- 4. Registration **occurs online**, using our electronic system Humanitix https://humanitix.com/au
- 5. People who have difficulties with the electronic form should contact us on wa.familypathwaynetwork@relationshipswa.org.au, for individual assistance. Note: our team are not available every business day.
- 6. Payments must be made **online** via the electronic registration system. This electronic payment system is used because it keeps administrative costs down and therefore minimises registration fees.
- 7. Places cannot be held without payment.
- 8. Delegates unable to pay online **may request an invoice.**

Metro vs Regional Registrations

Delegates may register to attend **in person at our metro location** (Perth) *Please note: a livestream will not be available this year.

- 9. In the event of a **COVID lockdown impacting Perth**, or other major event meaning that the face-to-face conference cannot proceed in Burswood, the conference **is likely to be cancelled, in which case partial refunds would be offered.**
- 10. Should you become unwell we recommend you do not attend the event. Refund or reimbursement will not be available, instead you may transfer your ticket to another colleague. In this instance, please advise the new attendee's name, role, and dietary requirements via email at <a href="https://www.wav.new.even.edu/wav.new.edu/wa
- 11. Please note that legal CPD points apply for **attendance to those who can provide a relevant PID**. CPD points for other professions may be available as advised by your industry peak

Cancellations

- 1. Cancellations received in writing (<u>WA.FamilyPathwayNetwork@relationshipswa.org.au</u>) by **29 April 2025** will be accepted and all fees refunded.
- 2. Cancellations received after **29 April 2025** will not be refunded but may betransferred to another person in accordance with clauses 17 and 18.

Changes to details and preferences

- 3. Electronic changes to conference delegate registrations may be made up until **5pm 29 April 2025**. Changes should be made using the "edit" function available for your booking in the online registration system and do not incur a charge.
- 4. After **29 April 2025**, electronic changes will not be possible, meaning custom details such as name badges and dietary requirements may not be able to be accommodated. However, in the case of last-minute issues, an alternative delegate may be sent on the day to replace someone unable to attend.

Photography and video

- 5. Photographs and video will be taken by FLPN / Known Associates at the conference and used for reporting, showcasing and promotional purposes.
- 6. By registering, delegates are acknowledging that they may be photographed at some point during the conference.
- 7. Our photographer will make every effort to ensure consent. However, consent from individuals is not usually practical for large group and crowd shots.
- 8. If you do not wish to be photographed, please just inform the photographer, who will ensure you are not captured.

Accommodation and travel

- 9. This is a non-residential conference and all accommodation, travel and transport arrangements and any associated costs are the **responsibility of the individual delegate,** except where otherwise specifically agreed to by FLPN.
- Delegates from outside Perth need to organise their own travel and accommodation and everyone is responsible for their own transport to and from the event venue.
