### Building evidence for family group decision-making in child welfare: operationalizing the intervention

Family group decision-making (FGDM) is a system reform strategy that positions family groups as decision-making leaders in family meetings, based on family-centered, strength-based, culturally relevant principles. Evidence of outcomes of family meetings is equivocal due to the differences in models and insufficient operationalization of core components. An important phase of intervention research mandates the importance of clearly operationalizing the intervention before efficacy or effectiveness can be evaluated. Using the framework for building evidence in child welfare, this paper reports on operationalization of core components of FGDM designed to serve three target child welfare populations.

### The Hague Convention and Transnational Custody Disputes

Adopted on October 24, 1980, the Hague Convention on the Civil Aspects of International Child Abduction was designed to address the problem of international parental child abduction. The Convention places a premium on prompt return in circumstances where a child was removed from one jurisdiction by a parent – the jurisdiction of “habitual residence” – in breach of the custody rights of the “left behind” parent. Once returned, custody can be determined by the relevant authorities in the jurisdiction of habitual residence. Habitual residence is central to the operation of the Convention, since the return mechanism in art. Twelve will only be triggered when a child is wrongfully removed from their State of habitual residence. The Supreme Court of Canada applies the “hybrid approach” to determining habitual residence, which treats the circumstances of the children and the intentions of the parties as factors to be considered in achieving a just result which fulfills the objectives of the Hague Convention. Under the hybrid approach, the court has the task of determining the focal point of the child’s life immediately prior to the removal or retention. The child’s perspective is thereby put squarely at the centre of Convention applications. Canada’s approach represents an evolution from the formalism of early cases to a recognition that the best interests of children generally is not a substitute for the best interests of the particular children before the court.

### Intensive intervention with families experiencing multiple and complex challenges: An alternative to child removal in a bi- and multi-cultural context?

In New Zealand, families facing possible child removal experience multiple challenges including poverty, family violence, parental mental health and substance abuse issues and historical and inter-generational trauma. Lack of resources to facilitate the intensive intervention needed to address such complexity increases the risk that removal is seen as the only way to ensure safety. Criticism of increasing removal rates for young children with significant over-representation of indigenous children has led to allocation of funding to establish Intensive Intervention services. New Zealand has a history of importing ‘evidence-based’ models from other countries. A review of what is currently known about intensive intervention with families where there is risk of a child removal was undertaken to explore the challenges that might arise in our bi- and multi-cultural environment. Critical factors for effective intervention are discussed before concluding with consideration of implications for other countries with histories of colonization and culturally diverse populations.

### Joint Select Committee on Australia's Family Law System Releases Second Interim Report

The Joint Select Committee on Australia's Family Law System was appointed by resolution of the Senate on 18 September 2019 and resolution of the House of Representatives on 19 September 2019.

The committee was originally due to present its final report on or before 7 October 2020. On 31 August 2020, both Houses of Parliament agreed to extend the reporting date to 25 February 2021.

The committee tabled its [first interim report](#) on 7 October 2020.

The committee tabled its [second interim report](#) on 15 and 16 March 2021. The second interim report details the committee's views and recommendations on the family law system. This concludes the committee's inquiry into the family law system.

On 22 and 23 February 2021, the Parliament agreed to extend the presentation of the final report until 30 June 2021. The committee intends that the final report will outline the committee's views and recommendations on the child support system and its interaction with the family law system.

### Consultation Paper Released: Establishment of an Accreditation System for Children's Contact Services

The Government is committed to ongoing improvements to the family law, courts and legal assistance systems to ensure that they help families separate in a safe, child-centred, accessible, and timely way. To this end, the Attorney-General's Department is pleased to announce the release of the consultation paper; *Establishment of an Accreditation Scheme for Children's Contact Services*.

The paper is intended to start a dialogue between the department and the family law services sector in order to establish the key issues within the industry and begin developing options for an accreditation scheme. As WAFLPN is made up of family law service practitioners, the department is interested in the views of the Network and its members.

The consultation period commenced on **21 March 2021** and will run until **14 May 2021**. Family law service practitioners are invited to participate in the consultation process and provide their feedback.
