# Current Research Updates on FASD – A Disability Rights Lens

Presented by Professor Dorothy Badry, University of Calgary

Research on FASD is growing at a fast pace and current research in the areas of FASD and child welfare, justice, mental health and suicide is the focus of this presentation.

Several high-profile media cases in Australia are identified in the presentation as systems continue to struggle in responding effectively to the needs of this population.

This population is vulnerable to engagement in key sectors including child welfare, justice, and mental health yet FASD continues to be an underrecognised disability globally.

Individuals living with this disability have a right to have their disability recognised and for effective supports to be provided in their care.

Professor in the Faculty of Social Work at University of Calgary, Dorothy Badry (PhD, MSW, RSW) is also the child welfare research lead for the Canada FASD Research Network.

Her research focus is primarily on FASD and child welfare, disability, advancing knowledge on FASD, issues of loss and grief, Indigenous concerns and FASD, international collaboration and FASD and suicide.

# **Lighthouse Project Update**

The Court is committed to the protection of vulnerable parties and children in family law proceedings.

The Federal Circuit and Family Court of Australia (the Court) are leading the way in helping families that have experienced family violence and other safety risks to navigate the family law system.

The Lighthouse Project will play a central role in the Court's response to cases which may involve family violence, by shaping the allocation of resources and urgency given to such cases.

It will improve the safety of litigants who may have experienced family violence and children who may have experienced associated risks such as child abuse.

# De facto couples now captured under superannuation splitting laws

Western Australian separating de facto couples will be able to split their superannuation in the same way as their eastern States counterparts following the passage of new laws through State Parliament.

There are more than 200,000 Western Australians in de facto relationships. The long-anticipated reform will mean they are no longer disadvantaged with regard to splitting superannuation assets in the event that their relationship breaks down.

Prior to the reform, the Family Court of Western Australia was unable to make an order splitting superannuation assets when it came to de facto couples. This was in contrast to married couples in WA, as well as married and de facto couples elsewhere in Australia.

The substantive provisions of the new law, although passed, will commence on a date to be proclaimed by the Governor.

# Attachment Theory: 2021 International Consensus Paper discussion in Perth

On 30 June 2022, Ngank Yira Institute for Change at Murdoch University, hosted a round table discussion in which the Minister for Child Protection, Simone McGurk, took part to consider the international research and Western Australian experiences of the misapplication of Attachment theory.

The basis for this discussion was the 2021 International Consensus paper by T. Forslund et al 'Attachment Goes to Court: child protection and custody issues with one of the authors of the paper addressing the round table.

This issue needs further discussion and consideration, especially in how Attachment theory is misapplied with Aboriginal and Torres Strait Islander families with devastating effects.

# Bias against Indigenous Australians: Implicit association test results for Australia

# **Abstract**

Reported experiences of discrimination amongst Indigenous Australians may reflect an implicit bias inherent in Australian society.

Such a bias may predispose vast swathes of the population towards considering Indigenous Australians through a negative lens, perhaps unconsciously.

This paper explores previously unpublished data from the internationally renowned Implicit Association Test that attempts to measure the implicit biases that Australians may hold against Indigenous peoples.

Other data collections on this issue focus on self-reported experiences of discrimination from the victims of verbal or physical racially motivated abuse (e.g. the Australian Reconciliation Barometer).

This new data source, which comes from the social psychology domain, provides a means to measure the positive and negative implicit associations that Australian participants make about Indigenous and Caucasian Australians.

The data reported in this paper contains observations from 11,099 unique individuals captured over the last decade across different cross sections of the Australian population, including based on gender, age, ethnic background, education level, occupation, religion

and political leaning.

The findings of this paper suggest that most Australian participants on average - regardless of background - hold an implicit bias against Indigenous Australians.

An attitude toward people or associating stereotypes with them without our conscious knowledge is known as Implicit (or unconscious) Bias. These terms refer to various social stereotypes and judgments that people unknowingly assign to others based on various factors that include age, gender, race, physical appearance, demographic status or sexual orientation.


