Will Somebody Please Think of the Children?! Child Focused and Child Inclusive Models in Family Dispute Resolution

In 2006, the Australian Federal Government made family mediation compulsory before pursuing litigation concerning parenting matters. Since then, much has been written about the benefits of mediation, such as the advantage of parents being empowered to make their own decisions rather than have the decision made for them by a court. The benefit of listening to children in family law court proceedings has also spawned considerable useful literature.

However, less attention has been given to the importance of empowering children to participate in the decision-making process in matters affecting them before the matter reaches court. Giving children a voice in the pre-trial stage is particularly important now that mediation is compulsory and because most family disputes are settled outside the courts.

Accordingly, this article focuses on the pros and cons of including children in family mediation. It also highlights how, when implementing family law reforms, Australian legislatures missed the opportunity to promote a culture of child inclusion in mediation. A child inclusive culture would have been in furtherance of Australia's international law obligations to protect children's participatory rights in matters affecting them.

Direct cross-examination in family law matters: Incidence and context of direct cross-examination involving selfrepresented litigants

This report sets out findings from the Direct Cross-examination in Family Law Matters project, which was commissioned and funded by the Australian Government, Attorney-General's Department. The project explores quantitative and qualitative data relevant to direct cross-examination involving selfrepresented litigants in family law matters, derived from court files and audio and transcripts of proceedings, collected from the Family Court of Australia (FCoA) and the Federal Circuit Court of Australia (FCCoA), together with an analysis of relevant unreported judgments of the Family Court of Western Australia (FCoWA).

The data analyses were undertaken to explore: the extent to which direct cross-examination was a feature of matters involving self-represented litigants in families characterised by alleged or substantiated family violence; and the factual and legal context characterising these family law

matters as compared to those matters where direct crossexamination involving selfrepresented litigants did not take place.

Gender in the Context of Same-Sex Divorce and Relationship Dissolution

This article identifies ways that judges, lawyers, researchers, and policy makers may attend to the role of gender and gender dynamics facing same-sex couples upon divorce or other relationship dissolution. When same-sex couples marry, the legal system and society at large may project conceptions of gender onto same-sex couples, often in a manner that conflicts with couples' intentions and practices. Gender and gender dynamics may affect the bases for dissolution, the financial aspects of dissolution, and the determination of child custody. The article also suggests directions for future research on the impact of gender on the dissolution of samesex relationships.

Australian Law Reform Commission Review of the Family Law System eNews

On 9 May 2017 the Turnbull Government announced its intention to direct the ALRC to conduct the first comprehensive review into the family law system since the commencement of the Family Law Act in 1976, with a view to making necessary reforms to ensure the family law system meets the contemporary needs of families and effectively addresses family violence and child abuse.
