

### 2017 Annual Conference Recap

Professionals from across the WA family law sector gathered at the University Club of WA on May 25 for 'Exploring solutions to complex problems: Responding to alcohol and other drugs in the family law system', WA Family Law Pathways Network's annual conference. A crowd of more than 250 delegates filled the auditorium as WAFLPN Chair and MC for the day, Kate Jeffries, kicked off proceedings. Following a beautiful Welcome to Country from Denice Kickett and Nigel Wilkes, Assistant Police Commissioner Michelle Fyfe took the stage to present the official opening. Ms Fyfe's opening presentation was insightful and informative, and put the theme of the conference in context with a look at how WA Police act as the frontline response to alcohol and other drugs

Following Ms Fyfe's presentation it was time for our keynote address from the National Drug Research Institute's Dr Nicole Lee. Dr Lee's presentation helped to contextualise some of the data we hear about drug use in the media, and explained the way that



methamphetamine affects the neurological functions of the user.

Soon it was time for morning tea, and the delegates spilled out to enjoy the sunshine, cakes and a cup of coffee in the University Club courtyard.

When the delegates returned to the auditorium it was to hear a copresentation from Magistrate Calverley of the Family Court of WA and Magistrate Horrigan of the Children's Court of WA on how they manage drugs and alcohol as a cross-jurisdictional issue. An insightful presentation leading to a fiery Q&A, this session got the crowd's blood moving. Next to take the stage was Gary Kirby, Director of Prevention Services at the Mental Health Commission, who took the audience through issues around comorbidity on a local level.

The fabulous weather prevailed and delegates were able to enjoy a delicious lunch on the lawn, networking with colleagues and sharing insights from the conference so far.

The lunch hour flew by, and soon it was time for delegates to head to their elected breakout sessions. In the theatre, MC Kate Jeffries hosted a panel of local drug and alcohol service providers including Christine Ockenfels, Roslyn Maloney, Tom Hopkins and Daniel Morrison. Delegates also packed in to see Professor Daniel Fatovich present on recreational drugs in the emergency



department and Heather Jacobson's presentation on family inclusive practice in the seminar rooms.

Following a cup of tea and a snack, the delegates returned to the auditorium for the final session of the day. Facilitated by Jill Rundle, an expert panel including Daniel Morrison, Michele Cohen, Richard Bannerman, Nicole Lee and Linda Jackson discussed a case scenario, which followed the story of a young family with drug and alcohol issues as it navigated the family law system.

With the proceedings at a close, a few members of the network and steering committee ended the day by sharing a drink on the terrace.

# How mothers perceive their own domestic violence victimization and how it impacts their children

Children's exposure to domestic violence has been associated with various negative outcomes. This study explores the effects of children's exposure to domestic violence through the lenses of the primary victims of abuse. Specifically, the consequences associated with their children's exposure to domestic violence, the coping mechanisms employed, and identified preventative measures to address this social problem. Semistructured interviews were conducted to obtain the mother's perspective. Participants for this study were randomly obtained from the database of the Legal Aid and Advisory Authority. Findings revealed that children are used as a bargaining tool by both mothers (to prevent DV) and perpetrators (to exert control). The coping mechanisms that mothers believed their children used included listening to music, adopting care taking roles, and positioning themselves away from the violence.

This article explores the current approach by New Zealand courts to the "grave risk" exemption in cases of domestic violence. New Zealand courts, similarly to other jurisdictions, have adopted a narrow approach, requiring the abductor to show that the habitual residence cannot adequately protect the child, in order to establish the defence. Due to the principle of comity, which emphasises respect for another nation's legislative and judicial jurisdiction, it is rare that courts will make such a finding as this may be seen to undermine the principle. Thus, the current approach effectively blocks the latter discretionary inquiry which balances Convention purposes and a child's welfare and best interests in deciding whether a return order should be made.

The lived experience of nonoffending mothers in cases of intrafamilial child sexual abuse: Towards a preliminary model of loss, trauma and recovery The non-offending mother in cases of intrafamilial child sexual abuse has received limited empirical attention in comparative to the considerable body of literature examining victims and perpetrators of child sexual abuse. There is growing evidence that demonstrates that nonoffending mothers' experience significant loss and trauma following the discovery of their children's sexual victimisation by a family member, particularly where the perpetrators are their partners. An understanding of the non-offending mother's experience is crucial to guiding statutory agencies and therapeutic interventions when working with these families. However, there is currently not a model or framework that conceptualises mothers' post-discovery experience, and the factors that might impede or facilitate their recovery. The aim with the present study was to address the gap in the existing literature, by conducting an exploratory investigation of the lived experience of non-offending mothers in order to generate a preliminary model outlining their recovery journey in the aftermath of discovery, drawing from existing theories of loss and trauma
