National FLPN Webinar and Screening of 'The Kinchela Boys' Short Film: Restoring our Family Structures

The Family Law Pathways Networks across Australia invite you to join the screening of 'The Kinchela Boys' short film followed by a webinar discussion with the Kinchela Boys Home Aboriginal Corporation. The webinar will include:

- Accounts from survivors of the Kinchela Aboriginal Boys Training Home (KBH) Uncle Roger Jarred, Uncle Bobby Young and Uncle James Welsh.
- A screening of 'The Kinchela Boys', a short animated film that was co-written, animated and produced by KBH survivors who tell of their experiences at the KBH and about their lives since.
- A live Q & A with Uncle James Welsh, KBH Kin Connect Team Leader, Lesley Franks, whose father attended KBH.

Kinchela Boys Home Aboriginal Corporation (KBHAC) was established in 2003 by Stolen Generation survivors of KBH, an institution on the Mid North Coast of NSW that was run by the NSW Government for over 50 years to house Aboriginal boys forcibly removed from their families. KBHAC supports KBH survivors who live across NSW and interstate, as well as their descendants and immediate families who live throughout Australia.

Safe and Together Addressing ComplexitY focussing on Children (STACY for Children)

This project explored the co-occurrence of domestic and family violence (DFV) when parents have challenges relating to mental health and the problematic use of alcohol and other drugs. In the context of families, these issues significantly impact children. However, in adult-focused services there is a tendency for the needs of children to become invisible. The project found evidence that a coordinated approach is needed to address these complex intersecting issues and to enable practitioners to work with each individual member of the family. The study found that when the Safe & Together Model™ is implemented holistically, with strong collaborative practice across agencies, it leads to better outcomes for children and families affected by DFV and parental alcohol and other drug use, and/or mental health challenges.

The Intersection of Intellectual and Developmental Disabilities with Child Exposure to Intimate Partner Violence: Implications for Research and Practice

Although the body of research on children exposed to intimate partner violence and factors that enhance their resiliency is growing, little is known about children with intellectual and developmental disabilities who have also been exposed to violence. This knowledge gap is notable given the prevalence of intellectual and development disabilities among children, as well as the numerous challenges facing these children and their families (e.g., medical and behavioral challenges, parenting stress, and financial burden). Informed by prior research and the authors' practice experience, this article highlights information for service providers working with families experiencing both intimate partner violence and intellectual and developmental disabilities. In addition to providing an overview of children's exposure to intimate partner violence and an overview of intellectual and developmental disabilities, this commentary summarises the limited research exploring the intersection between these two issues and offers recommendations for enhancing research and practice. Recommendations center on the importance of training, wrap-around and tailored services, community partnerships, and intervention research focused on survivors and their children with intellectual and developmental disabilities.

Crisis for a System in Crisis: Forecasting from the Short- and Long-Term Impacts of COVID-19 on the Child Welfare System

The COVID-19 pandemic has thrust the world into a crisis – and the child welfare system is particularly susceptible to its effects. This pandemic has exacerbated some of the most problematic aspects of the system, and its impacts will reverberate long after the immediate crisis ends. As COVID-19 spread, families were instantly impacted – in-person family time was cancelled, youth and families were unable to access basic resources, services, and technology, and access to the courts was curtailed. Those short-term effects may give way to long-term harms such as disrupted attachments and delays in achieving permanency. The pandemic also reinforced the importance of key tenets of a well-functioning child welfare system: high-quality legal representation, creativity, and youth and family engagement. Attorneys must learn from the fallout of the pandemic, retain the best responsive practices, and use the lessons learned from this crisis to transform dependency cases, and the system writ large, into what families need and deserve.

New ANROWS research grants open: A focus on children and young people

ANROWS is [calling for grant applications](#) from researchers across Australia for its 2020–2022 ANROWS Core Grant Research Program.

Grants are available for projects that will investigate the impacts on and needs of children and young people who are exposed to violence against women, especially those from marginalised communities.

A total pool of \$1.157 million is available. Funds for the [2020–2022 ANROWS Core Grant Research Program](#) have been provided to ANROWS jointly by the Australian Government Department of Social Services and the governments of all states and territories.

Funding will be prioritised for projects focussing on effective strategies that prevent and respond to:

- the impacts of exposure to violence against women on children and young people in marginalised populations
- harmful sexual behaviours of children and young people
- violence against women perpetrated by children and young people.

The grants round will also seek applications for research projects that address intersections of inequality and disadvantage for marginalised populations.

ANROWS has identified these issues as an urgent research gap through [Australia's National Research Agenda to Reduce Violence against Women and their Children 2020–2022](#) (ANRA), which has also been released today. ANRA was developed through an extensive review of current literature and wide consultation with researchers and policymakers working on violence against women.

Funded projects are to commence in early 2021 and final reports, following peer review, are to be submitted no later than 31 March 2022.

Applications will be accepted until 11:59pm (AEDT) Monday, 9 November 2020. No extensions will be granted.
