Get to know our conference speakers

David Mandel

David Mandel has been working in the domestic violence field for 25 years.

David's international training and consulting focuses on improving systems' responses to domestic violence when children are involved, and responsible fatherhood. David has developed the Safe and Together™ model to improve case practice and cross system collaboration in domestic violence cases involving children. David and his staff have consulted to United States' child welfare systems in a number of states including New York, Louisiana, New Jersey, Wisconsin, Colorado, Connecticut, Florida, Vermont, Oregon and Ohio. This includes overseeing a statewide network of domestic violence consultants for the Connecticut Department of Children and Families; training domestic violence subject matter experts for Florida's Department of Children and Families; improving collaboration between child welfare and domestic violence advocates in Colorado; and the development of certified Safe and Together trainer network to support the roll out of differential response in all 88 Ohio county child welfare agencies. David Mandel and Associates collaborates with domestic violence agencies such as the Florida Coalition Against Domestic Violence and the Ohio Domestic Violence Network. In 2012, David Mandel & Associates also provided training in the United



Kingdom, the Republic of Ireland and Singapore. David has written journal articles on batterer's perceptions of their children's exposure to domestic violence and the intersection of domestic violence and child welfare practice. His chapter on "Batterers and the Lives of Their Children" was published in the Praeger Series Violence Against Women in Families and Relationships

Catherine is a full member of the Australia Psychological Association (APS), the Australian Association for Cognitive Behavioural Therapy (AACBT) and the Association for Contextual Behavioural Science (ACBS). She also provides supervision and training for clinical psychologists.

Catherine has worked in a range of sectors as a clinical psychologist. She has worked in hospital, educational and community settings prior to working in private practice. Catherine now works exclusively in private practice as Principal of The Relationspace.

Catherine has authored a number of papers in the field of clinical psychology. She frequently appears in the popular media providing commentary on parenting and family relationships. She speaks at conferences and workshops on topics of child development, parenting and clinical intervention in high conflict families.

The economic consequences of divorce in six OECD countries

This report presents a cross-national comparison of the short- and medium-term economic effects of divorce.

Estimates for men and women are derived from longitudinal data from Australia, Germany, Korea, Switzerland, the United Kingdom, and the United States.

It details how the main sources of income for women change following divorce, and the relative contribution of these sources. The findings show that though divorce has a negative effect on the equivalised household incomes of women in all of these countries, the extent and duration of these negative effects differ markedly between the nations.

The report concludes by briefly considering the possible causes of these differences.

A review of kinship carer surveys: The "Cinderella" of the care system?

Across the English-speaking world, child protection authorities are increasingly placing children with extended family rather than in foster care or residential care. Many more children are in such arrangements informally. A number of surveys of kinship carers have been conducted in recent years in Australia, New Zealand and the United Kingdom. This paper systematically reviews these surveys to identify messages for policy and practice about the characteristics and support needs of kinship care families. Some comparisons are made with population studies of kinship care. The review will be of interest to Commonwealth and state government policy-makers, service providers and caseworkers, as well as kinship care families.

Children Resisting Contact With a Parent Postseparation: Assessing This Phenomenon Using an Ecological Systems Framework

The process of separation and divorce demands significant changes among family relationships requiring the ongoing negotiation of roles and responsibilities. Most children of separated parents will continue to want contact with both parents, but a small subgroup of children will align with one parent and simultaneously resist or reject the other. Several names and etiological suggestions have been coined to label these extreme alignments, but many of these oversimplify the complexity of these strained parent-child relationship dynamics. This article critically reviews the research literature using an ecological systems framework to better understand the nature of these complex strained parent-child relationships. Courts, legal, and mental health professionals that work with these families are encouraged to assess and respond to these dynamics using an ecological approach.

Webinar: Child Custody Evaluations and Domestic Violence: New Research and Implications for Practice

AIFS presents Professor Daniel Saunders, School of Social Work, University of Michigan, U.S.A.

When couples separate, the risk of intimate partner violence, abuse, harassment and homicide often continues or increases.

Safety and human rights concerns in custody-visitation proceedings are gaining increased attention because professionals often do not detect abuse, do not take it seriously, or apply non-legal factors in their determinations.

This presentation will highlight new research findings on child custody evaluations in cases involving domestic violence, focusing on the beliefs and recommendations of the professionals involved in these determinations. Implications of the research for policy and practice will be described.
