### WAFPN one day conference Bringing perpetrators into view: Developing a web of accountability

WAFPN presents 'Bringing perpetrators into view: Developing a web of accountability', a one day conference to discuss options and opportunities for responding more consistently and effectively to perpetrators of family and domestic violence.

Based on a report by the RMIT Centre for Innovative Justice titled Opportunities for Early Intervention: Bringing perpetrators of domestic violence into view, this conference will build on David Mandel's safe and together model and explore how perpetrator accountability can be increased across the service system including family law.

Topics explored will include:

- Introduction of National Outcome Standards for Perpetrator Intervention
- Research and practice learnings about engaging and responding to perpetrators of family and domestic violence in voluntary, statutory and legal/justice settings
- Contemporary thinking and practice about dedicated perpetrator interventions including men's behaviour change programs.

### Meet our speakers: Elena Campbell

Former lawyer, speechwriter and ministerial staffer, Elena Campbell has worked in social and legal policy for over fifteen years. With particular experience in equal opportunity, human rights, family violence reform and other areas of social justice,



Elena has also worked as a consultant writer and editor for a range of organisations, including the Australian Human Rights Commission.

Recently assuming the role of Manager, Policy and Research, at RMIT's Centre for Innovative Justice, Elena is also the author of a number of the CIJ's reports, including its most recent, Opportunities for early intervention: bringing perpetrators of family violence into view.

Launched by Australian of the Year, Rosie Batty, the report is gaining significant traction at both a state and national level for its distinct focus. Elena is currently completing work concerning ways in which to measure justice mechanisms more effectively and is also engaged in a number of other projects related to the impacts of family violence, including the consequences of intergenerational victimisation on women and children who have been caught in the cycle of the criminal justice system.

Plus panels featuring key men's behaviour change program providers and justice system stakeholders to discuss their response to perpetrators of family and domestic violence.

## Gender-sensitive intervention to improve work with fathers in child welfare services

Although the importance of including fathers in child welfare services has been increasingly recognized, social workers' engagement with fathers is still limited and sometimes fraught with negative bias. This paper attempts to lay some needed foundation to meet the challenge of working with fathers. It presents in succinct form the existing knowledge on how fathers experience and manifest their distress and on how they view the social services and social workers. It discusses, in some detail, three main issues - power relations, mutual fear and communication differences – in the interactions between female social workers and the fathers in the social welfare services. And it emphasizes the need for social workers to be aware of how their experiences with their own fathers may affect their interventions with men. It ends with observations and recommendations for developing the gender awareness that is necessary for effective practice with fathers.

# The Diverse Fathering Practices of Men Who Perpetrate Domestic Violence

Quantitative and qualitative data were gathered from in-depth interviews with 17 Australian fathers who were participating in a men's behaviour change program. The study found that men's fathering varied and posed significant, yet different, risks to women, children, and young people. Variations were particularly evident when analysing narratives of masculinity with perceptions of control over the use of domestic violence. Other aspects of men's identities such as class, culture, and health intersected with gender and contributed to the diversity of harmful fathering practices. This paper spotlights the substantive issue of men's domestic violence and its impact on all aspects of family life, rather than current practices which frequently focus on women and their mothering practices.

This reports presents key findings and recommendations of research conducted in 2012-2014 by the Indigenous Legal Needs Project (ILNP) in Western Australia. The ILNP aims broadly and on a national level to: identify and analyse the legal needs of Indigenous communities in non-criminal areas of law (including discrimination, housing and tenancy, child protection, employment, credit and debt, wills and estates, and consumer-related matters); and provide an understanding of how legal service delivery might work more effectively to address identified civil and family law needs of Indigenous communities.

Survey: Female survivors of domestic/family violence, family courts and cross examination

WOMEN'S LEGAL SERVICES AUSTRALIA (WLSA) needs your help. WLSA is a network of specialist community legal centres that provide free legal advice and information to women in Australia.

WLSA advocates on safety in family law. One of WLSA's current concerns is there is no specific protection in family law preventing a perpetrator of family/ domestic violence who is representing themselves without a lawyer, from directly cross examining the victim/ survivor at trial. This can retraumatise the victim/ survivor and has a lot of other concerning consequences for the victim/ survivor and their children, the ultimate court outcome and on the family law legal system as a whole.

WLSA is interested in gathering more information about the extent this is happening and the impact it has on victims/ survivors of violence. WLSA hopes this evidence will help convince decision-makers about the need for the law to be changed to stop this from occurring in the future.

## ICYMI: Federal Government's Women's Safety Package to Stop the Violence

On September 24 Prime Minister Malcolm Turnbull announced a new funding package to address family and domestic violence.

Submitted as a joint release with the Minister for Women, the Attorney General, the Minister for Health, the Minister for Social Services, the Minister for Indigenous Affairs, the Minister for Communications and the Minister for Education, the \$100 million package is intended to create a 'safety net' for women and children at high risk of experiencing violence.
